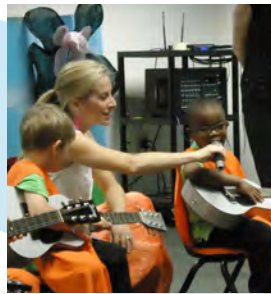

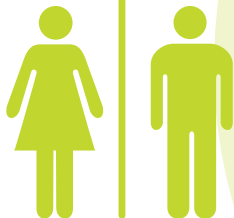


CVI reached **3,115** people in the community through public education activities like CVI tours, health fairs and United Way events.

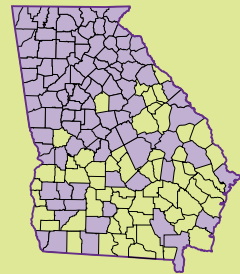
Income

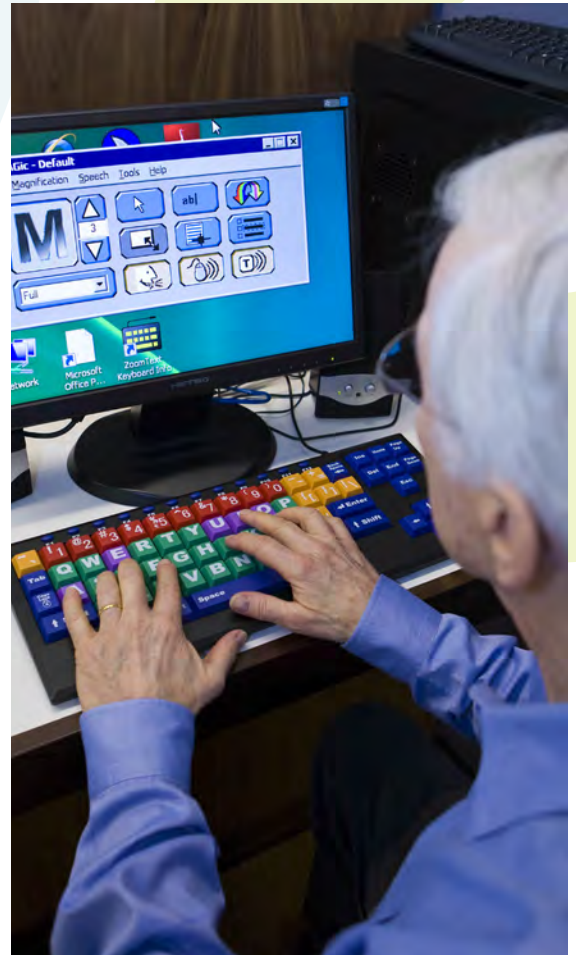
