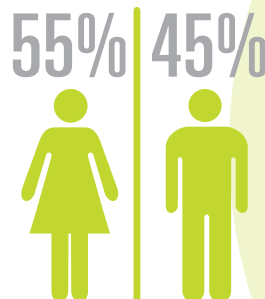

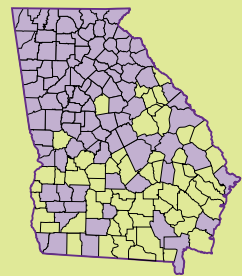

CVI assisted people from 68 of Georgia's 159 counties, as well as people from 8 other states.



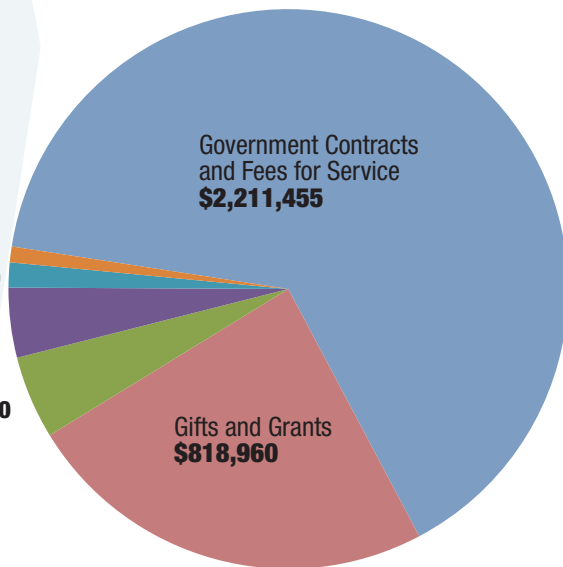

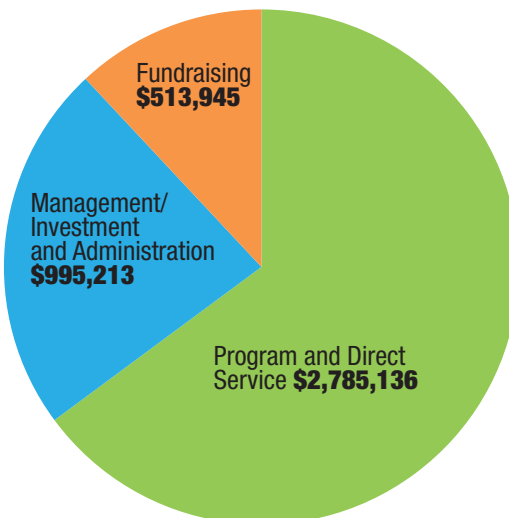

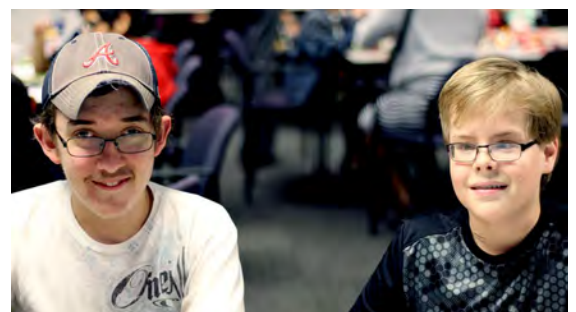
